Satilla Regional water supply is from a groundwater source drawn from the Floridan Aquifer by five 800' (ft) deep wells. This provides the Water & Sewer Authority with a safe and dependable supply of water even in the driest years. Source is free from potential sources of contamination and meets requirements of Wellhead Protection Plan. This information is on file and available at our office.

Treatment Process

The clear water is pumped & disinfected with chlorine gas to make the water biologically safe, and there is a natural fluoride residual of 0.4 to 0.6 mg/l.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Satilla Regional Water & Sewer Authority is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested.
